Min 05/20 REACH & GHS

DE gave an update regarding the ongoing Cobalt issues. The RAC (Risk Assessment Committee) have recommended to use a limit value for cancer (0.5 μ g Co/m³ respirable, with cancer risk) based on a breakpoint approach and a limit value for non-cancer effects in the upper respiratory tract (1 μ g Co/m³ inhalable). Both of these limit values are 8-hour time-weighted averages (TWAs), like that of an OEL. The RAC's view, although they supported an EU wide OEL, was that the Restriction is currently the most appropriate EU-wide measure to address the 5 Co salts.

The SEA, through its European Association, CETS, is in discussions with the European Chemicals Agency (ECHA) and European Commission with a view to holding a workshop in April 2020 in Frankfurt, Germany to try and resolve the outstanding chromium trioxide authorisation applications. The provisional dates are 23rd & 24th April 2020. An agenda and guest list is being developed and it is anticipated that around 50 people will attend.

The Chancellor, Sajid Javid, has stated that there will not be regulatory alignment with the EU after BREXIT and that companies will have to adjust to new regulations. As there is a transition period until the end of 2020 and negotiations on a trade deal are still ongoing, this may just be part of the negotiating strategy. However, this could mean that UK REACH is not aligned with EU REACH in the future. It is therefore vitally important that the applications for authorisation for chromium trioxide are approved by the EU before the end of this year so that they will then transfer into UK REACH. There is a meeting of the UK REACH X-Sector Group next week and DE will attend and get an update from DEFRA, BEIS and HSE.

Min 06/20 Industrial Emissions Directive (formerly IPPC)

DE reported that the Environment Agency had stated that the Metals Sector would be represented on the Regulated Business Forum by the UK Metals Council. Neither SEA not the NFA (Non-Ferrous Alliance) are members of the UK Metals Council and, as the two organisations represent over 75% of all IED permits in the sector, it would appear that this decision of the EA is not representative and was taken without consultation. The SEA will be taking this matter up with their President Lord Whitby.

Min 09/20 Environment Agency Matters

New Government:

The election has provided clarity about the way forward on EU Exit. We will now leave the EU on 31 January with a deal - the Withdrawal Agreement and there will be an Implementation Period until 31 December 2020, during which **EU law will continue to apply** in the UK and of course that includes environmental law.

The government's environmental agenda is also clear. The Conservative Manifesto reaffirmed the government's support for the 25 Year Environment Plan and an Environment Bill to guarantee its protection, to reform agriculture based on payments of public money to farmers for public goods, to invest in new flood defences, and to lead the global fight against climate change by hosting the UN Summit next year and achieving Net Zero by 2050. The EA will play a central role in the delivery of all these strategies.

Metals Climate Change returns

Coming out of the above, I have provided information from this sector to an information gathering exercise concerning industry actions to reduce greenhouse gas emissions and adaptive measures to manage the impacts of climate change. Responses will help identify levels of engagement, best practice and consistency of approaches across sectors, not just metals. This information will be used as an initial guide to inform on strategies and planning so we maximise what we do to drive the changes needed to achieve net zero.

In the near future I may be approaching you for support as we look at actions to reduce GHG emissions from both up and downstream activities not just the activities we regulate, as well as considering the whole life cycle of an operators' activities (e.g. supply/product chain, construction, operation, decommissioning).

Sector roadmaps

Defra's Clean Air Strategy, published in January 2019, committed us to working with Defra and industrial sectors to develop a series of ambitious sector roadmaps to make UK industry world leaders in clean technology and to secure further emissions reductions. Defra have initially identified 5 sectors for roadmaps: Refineries and downstream fuel; Iron and Steel Industry; Glass; Cement and Lime; Food and Drink; Paint and Coatings; Energy Generation; Ceramics; Chemicals. We and Defra are reviewing background data and evidence within Defra group before further external stakeholder consultation. We currently looking at:

- -Better understanding the current contributions from these specific industry sectors and LA-permitted activities.
- -Identifying any gaps in our data and understanding
- -Ensuring historic NAEI emissions are accurate and can be relied upon for future projections

These are the 5 initial sectors but in fact 'iron and steel' is only a subsector of the metals sector so its remit may be expanded at a later date to cover the whole sector.

Incorporation of climate change adaptation into EPR via permitting.

This came fully into effect for **new bespoke waste and installations applications** on the 1st December.

From this date, old style applications will no longer be accepted by us, so please make sure that you and your members are aware of the new arrangements. My inspectors will be informing operators when they next have contact.
